We are endeavouring to continuously reduce wastewater, noise and other emissions accordingly.

Swissgrid is committed to making responsible use of natural resources. To this end, we integrate the principles of the circular economy along the value chain by optimising resource efficiency, reusing and recycling materials and reducing waste.

Integration and focus

We use suitable tools to ensure compliance with and implementation of the chosen measures, the legal requirements and internal guidelines relating to sustainability.

Sustainability in corporate culture and behaviour

Swissgrid raises awareness among employees and motivates and encourages them to behave in an environmentally responsible, safety-conscious and sustainable manner. We provide regular information and organise training and further training to increase employees' skills and awareness of environmental protection, occupational health and safety, and sustainability in all areas of the company.

Due diligence

Swissgrid exercises strict due diligence when it comes to environmental and social impacts and risks along the value chain. We regularly carry out an assessment of actual and potential impacts, risks and opportunities in accordance with the concept of dual materiality. We pursue a risk-based, proactive approach in order to avoid and minimise negative effects.

Continuous improvement

Swissgrid endeavours to continuously strengthen and develop its commitment to sustainability and the related goals. To do so, we regularly consult internal and external stakeholders, including employees, industry partners, authorities and other interest groups.

Transparency

Once a year, Swissgrid publishes a transparent and comprehensive Sustainability Report in accordance with nationally and internationally recognised reporting standards.
