Maurice Dierick to become Head of Grid at Swissgrid

Within this role, he also helped companies in Switzerland for about 10 years and is therefore familiar with the local conditions. Most recently he worked on a transformation project for Western Power (Australia) on behalf of Ernst & Young in Australia. In February 2015, Maurice Dierick joined Swissgrid as Head of Grid Infrastructure where he was responsible for the entire infrastructure to the amount of CHF 2.5 billion, as well as planning and construction activities for grid projects.
