Swissgrid sets the tariffs for grid usage in accordance with the legal and regulatory requirements. Swissgrid is entitled to adjust the tariffs within the framework of the legal and regulatory requirements. Swissgrid generally notifies grid users about tariffs in writing three months at the latest prior to the legally prescribed date of publication for grid operators.

- 15 The penalty for non-compliant reactive energy for active participants is defined in Annex 4 of the PPO works agreement or Annex 3 of the DSO works agreement. Every five years, the penalty shall be reviewed and adjusted if necessary.

- 17 Up to and including 2016, a model with three balance groups was in force, the registration tariffs of which were constant from 2009 to 2016:
  - Registration tariff for standard balance group: EUR 6,250
  - Registration tariff for control balance group in addition to standard balance group: EUR 3,500
  - Registration tariff for CH 15 balance group in addition to standard balance group: EUR 3,500
- 18 The tariffs based on trade and consumption volumes and for clearing houses are no longer used from 2014 onwards, in line with the Swiss Federal Electricity Commission's directive about timetable management and the balance group, and they cease to be applicable from 2015 onwards. Additionally, no on-account billing rates apply for LTC holders (grid usage and loss of efficiency) from 2014 onwards, and no general ancillary service billing rate is used for power plants from 2011 onwards.
